- The kidney transplant program has seen over 4,000 successful transplants done. It has successfully performed transplants for as young as 14 months to oldest at 69 years
- Secunderabad unit is one of the few in the country to have 50 dialysis beds in a single location which operates 24/7.

All its hospitals are equipped with state-of-the-art medical equipment and employ practices and policies which help provide quality healthcare services to patients. It was the first hospital in Hyderabad to install 4-Arm HD da Vinci Robot technology at its hospital at Secunderabad. The flagship hospitals at Secunderabad, as well as the hospital at Rajahmundry and Kondapur have been accredited by the National Accreditation Board for Hospitals and Healthcare Providers, India ("NABH"). The hospital at Secunderabad is accredited with ISO 9001:2008 certification and has also been accredited by the National Accreditation Board for Testing and Calibration Laboratories ("NABL"). The Secunderabad flagship hospital has received the first Green OT certification in the state of Telangana and AP in 2016. The Operation Theatres are audited for their effective usage and disposal of bio medical wastage processes. It has received an award from the Association of Healthcare Providers (India) ("AHPI") for nursing excellence in 2016 and was ranked number one multi-specialty hospital in Hyderabad by the Times of India Survey in 2015. It has also has been designated as the laureate of the APSIC CSSD Center of Excellence Silver Award 2015-2016.
